I have no right to transfer my small vessel privileges.

Understand that failure to comply, with all of the above, may result in forfeiture of small vessel storage privileges and/or fines.

All of the above language is left to the interpretation of the current governing Board of the PPC/PPA and the Dock Master.

Hold Harmless Agreement: Lessee shall assume the risks of, indemnify PPC/PPA against, and hold PPC/PPA harmless from any and all claims, actions, suits, proceedings, costs, expenses, damages and liabilities, including and/or arising out of, connected with, or resulting from property leased from Princess Pocotopaug Corporation.

Warranty and Limitation of Liability: In no event shall PPC/PPA be liable for loss of use or for any indirect, incidental, or consequential damages, including but not limited to any damages for personal injuries. All other warranties, direct or implied warranties of fitness for a particular purpose are hereby excluded.
